THE RUB: A SHORT **AFRICAN AMERICAN HISTORY OF PIT MASTERS**

Barbecue has a long, rich history in the United States. In Fat Ham, Juicy's family owns a popular barbecue restaurant in town. The place is so well known and admired for its meats that a chain restaurant wants to buy them out. His father, Pap, and his uncle. Rev. who own and operate this restaurant, come from a family of expert Barbecuers commonly known as "pit masters." This term comes from the way the meat was originally cooked by digging a hole in the ground, chopping wood, and shoveling coal into it. The meat was placed on long sticks above the pit to cook "low and slow." To earn the title of Pit Master, a cook must be well respected in their community, town, or city for having the best-tasting barbecue and an excellent cooking technique, which may also include their original rub or sauce, which is placed directly on the meat (or on the side) for seasoning and added flavor, thus being recognized as a Master of the pit.

Barbecue originated in the U.S. with Native Americans, sometime between 1500 and the 1700s, with a method that was called "barbacoa." It was eventually learned by Africans who were enslaved and developed through their cooking for white slave owners. In its early days, barbecue was considered plantation feast food. Whole hogs were prepared to celebrate the end of summer growing season, holidays, or other special occasions at large gatherings for white families and neighbors. Though the barbecue cooking was "supervised" by a white man, he didn't actually do any cooking. In those days, Barbecue was hard work—from the pit digging, chopping of wood, shoveling, butchering, processing, and cooking. And while white slave owners willingly took part in the eating and celebrating, the labor was a different story. Slaves were the main cooks on the plantations and these celebrations were more labor intensive. The head barbecuer working the pit was often an elderly black man who was known as one of the best cooks on the plantation. Eventually, he was called a Pit Master, and the name stuck. When enslaved Africans got a pig of their own, they let no part go to waste, cooking and consuming the entire animal using creativity to create excellent dishes that made the least pleasant parts edible, which was essential for survival. These skills were vital after the end of slavery when black men and women needed to find a source of income to provide for themselves. These learned techniques were mixed with African and European styles to develop into modern barbecuing.

Post slavery, as our nation built up its infrastructure and highways and roads developed, African Americans used their passed-down barbecue skills to create roadside businesses selling food, where they could dig a pit and cook along the road itself. This time not only offering barbecued meats but also delicious sides that included greens, macaroni and cheese, baked beans, and potato salad. Although segregation slowed the growth of black pit masters in the earlier part of the century, the 60s and 70s brought the next generation who were ready to use those skills and knowledge to open restaurants across the U.S., with each region of the country delivering their own style of barbecue, different cuts, rubs, unique sauces, and flavor combinations. Today, we see many restaurants, food trucks, books, and television programming dedicated to barbecue.

Although the cooking methods have evolved over the years (most no longer cook from a dug hole but a metal pit or grill above ground), one thing is for certain, the black barbecuers have always been considered experts for centuries and have truly earned the title of "Pit Master."


